ORDER:

- 1. The "Annamacharya Institute of Technology & Sciences, Behind RTO office, Utukur Post, Chintakomma Dinne(V&M), Kadapa Dist" was given Temporary affiliation for running Degree courses during the academic year 2015-16 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2016-17 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2016-17 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2016-17. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2016-17 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 28-11-2016.

- 1. The College should apply for NBA& NAAC accreditation
- 2. Computer to Student ratio is to be maintained as per norms
- 3. WiFi facility to be provided to staff and students
- 4. Library automation software to be procured
- 5. e-journals to be procured as per norms
- 6. Reading room seating capacity to be increased to 180
- 7. Internet speed of 100 MBPS should be available as per norms
- 8. Faculty cadre ratio is to be maintained as per norms
- 9. Faculty student ratio has to be maintained as per norms for UG courses and M.Tech.-Structural Engg.

- 10. Atleast 50% of faculty appointments have to be ratified by the University.
- 11. e-class room is to be provided
- 12. Placement cell is to be established
- 13. Women Protection Cell is to be established
- 14. Staff Salaries are to be paid through bank
- 15. Qualified faculty to be appointed in Civil Engg. and Mech. Engg.
- 16. Sufficient and latest books need to be procured for the library
- 17. At least 3 legal system softwares and 20 legal application softwares to be procured with adequate number of licenses
- 18. At least 3 computer servers are to be procured
- 19. 7/22 faculty in ME and 9/17 in Civil Engg. are B.Tech. qualified
- 20. Aadhaar and PAN number has to obtained by all the teaching staff
- 3.
